



### **Declaration of Intent**

**Bright and clear, no receipt, no giving**

**Gifts of all kinds from performing duties(No Gift Policy)**

In order to ensure the operations of Thung Fon Subdistrict Municipality comply with the regulations of the Prime Minister's Office regarding the giving or receiving of gifts by state officials in the year 2001, in accordance with the Constitution on the prevention and suppression of corruption, concerning the receipt of property or other benefits by state officials under Article 103, the core values and organizational culture of Thung Fon Subdistrict Municipality, as well as in line with Indicator 10 on corruption prevention, Sub-indicator 10.1 on actions to prevent corruption in asset matters, the No Gift Policy, duty performance, and policies to combat corruption and all forms of corruption, stipulating that municipal staff must adhere to the principles of honesty, integrity, transparency, accountability, and adhere to ethical standards in governance. The Head of Thung Fon Subdistrict Municipality therefore issues the following announcement:

Article 1 prohibits executives, municipal council members, municipal employees, permanent employees, contract employees, teachers, and education personnel from accepting gifts or rewards from individuals or external agencies while on duty, before duty, and after duty, which may lead to corruption and misconduct.

Article 2 Giving gifts to individuals or external organizations can be done according to the norms, customs, culture, or etiquette practiced in society, and can be done without violating relevant laws

Article 3 refrains from accepting gifts or any other benefits in all cases, except where unavoidable, comply with relevant laws and regulations

Article 4 promotes giving blessings with blessing cards or using electronic media instead of giving gifts

Article 5 informs the policy of refraining from receiving and giving gifts, to be acknowledged by stakeholders through various channels for general awareness.

I, Mr. Sonong Panchiangwong, the headman of Thung Fon sub-district, hereby announce that the Thung Fon sub-district municipality will be an organization where all government officials do not accept gifts and rewards of any kind from performing their duties, before, during, and after duty, to prevent corruption and misconduct in the present and future. I express the intention to ensure that the personnel of Thung Fon sub-district municipality adhere firmly to the fundamental institutions of the country, including nation, religion, monarchy, and the democratic system with the King as the head. To be a good person, ethical, behave professionally with honesty and integrity as the core values, maintain dignity and humanity, stand firm in what is right, perform duties with honesty, transparency, uphold morality and ethics.

And I humbly vow to conduct myself in the footsteps of His Majesty the King, to uphold the royal institution and preserve the teachings of the virtuous kings, to live by the principles of sustainable economy with pure devotion, standing alongside the Thai people for the stability, prosperity, and sustainability of the Kingdom of Thailand.
